Limitations (AMC1 MED.C.035)

(MCL) - restriction to operate only in multi-cabin crew operations
(OOL) - restriction to specified aircraft type(s)
(OAL) - restriction to a specified type of operation
(TML) - requirement to undergo the next aero-medical examination and assessment at an earlier date than required by MED.C.005(p).
(SIC) - requirement to undergo specific regular medical examination(s)
(CVL) - requirement for visual correction
(CCL) - requirement for visual correction by means of contact lenses that correct for defective vision
(HAL) - requirement to use hearing aids
(SSL) - special restriction as specified

MED.A.020 - Decrease in medical fitness

(a) Licence holders shall not exercise the privileges of their licence and related ratings or certificates at any time when they:

- (1) are aware of any decrease in their medical fitness which might render them unable to safely exercise those privileges;
- (2) take or use any prescribed or non-prescribed medication which is likely to interfere with the safe exercise of the privileges of the licence;

(3) receive any medical, surgical or other treatment that is likely to interfere with the safe exercise of the privileges of the licence.

(b) In addition, licence holders shall, without undue delay, seek aero-medical advice when they:

- (1) have undergone a surgical operation or invasive procedure;
- (2) have commenced the regular use of any medication;
- (3) have suffered any significant personal injury involving any incapacity to exercise the privileges of the licence;
- (4) have been suffering from any significant illness involving any incapacity to exercise the privileges of the licence;
- (5) are pregnant;
- (6) have been admitted to hospital or medical clinic;
- (7) first require correcting lenses.

(d) Cabin crew members shall not perform duties on an aircraft and, where applicable, shall not exercise the privileges of their cabin crew attestation when they are aware of any decrease in their medical fitness, to the extent that this condition might render them unable to discharge their safety duties and responsibilities.
